This project consists of approximately 1,400 feet of concrete trapezoidal channel tying into the existing Reach 3A channel, a series of 18 excavated sediment basins and drop structures extending 12,350 feet upstream with soil cement bank protection on both sides 6,810 feet of low flow channel, maintenance road, access ramps, environmental corridor, and mitigation.

The estimated cost of this acquisition is between \$25,000,000.00 - \$100,000,000.00
